## Eligibility

Artists 50 years or over who live in the greater Chicago metropolitan area are eligible to enter.

## Media Requirements

Paintings, drawings, printmaking, mixed media, photography, fiber art and three-dimensional objects, including sculpture.

1. Work must meet professional framing standards and be ready to hang with wire firmly attached. **\*Plexiglas is highly recommended for framed artwork measuring over 16" x 20".**
2. Artists must supply pedestals for sculpture entries.
3. Work must have been completed after January 2007.
4. Work must not have been exhibited at any previous SAN art show.
5. Framed works cannot be larger than 48" (inches) on any side.

## Entry Fees

\$15 For 2010 SAN members.

\$50 Fee for non-members

## To Submit

1. Complete entry form(s) for one to three works.
2. Send an image of the artwork you wish to submit in one of these formats:

### ***SAN's preferred format is Digital.***

- **Digital images** may be submitted on-line or on a CD. Each image should be a minimum of 100 dpi/1 megapixel. Please list the file name for each piece on the entry form. Mail a copy of your entry form or confirmation along with your fees to the address listed under item #5 below.
  - **On-Line Submissions:** Log on to [www.SeniorArtistsNetwork.org](http://www.SeniorArtistsNetwork.org) and follow the instructions. You must follow-up by mailing a printed copy of your confirmation along with your payment by the deadline.
  - **CD:** send a CD of all images along with your entry form.
  - **35mm Slide** of each work you wish to enter. Label each slide with: Your name, title of work, medium, year of completion, and an arrow indicating the top of the slide.
3. Include a stamped, self-addressed envelope for the return of your slides or CD.
  4. Submissions should be post marked no later than August 5, 2010.

## Notification

- All entrants will be notified by phone or E-mail of the jury's decision by August 27, 2010.
- A maximum of 70 pieces will be exhibited, including a maximum of two pieces by any one artist.
- All slides and CDs of non-accepted work will be returned.
- Images of accepted work may be retained for promotional purposes at the discretion of SAN and submissions constitute permission for such retention and use.
